THIS AFFECTED APPROXIMATELY 610 MINNESOTANS, ALLOWING THEM TO TAKE CARE OF FAMILY, CHILDREN AND CONTINUE TO WORK WHILE THEIR CASES WERE BEING PROCESSED THROUGH THE COURT SYSTEM. ADDITIONALLY, MINNESOTA FREEDOM FUND GRANTED \$4,500,000 TO THE NATIONAL BAIL FUND NETWORK TO GIVE TO OTHER BAIL FUNDS AROUND THE COUNTRY.

PAYING IMMIGRATION BONDS. IN 2020 MINNESOTA FREEDOM FUND POSTED APPROXIMATELY \$2,070,000 IN IMMIGRATION BONDS, FREEING AN ESTIMATED 150 INDIVIDUALS, ENSURING THEY WERE NOT FURTHER HARMED BY OUR OPPRESSIVE FEDERAL DETENTION SYSTEM.
